**RESOLUTION NO. 2018-279**

**RESOLUTION DECLARING A SHELTER CRISIS PURSUANT TO SB 850 (CHAPTER 48, STATUTES OF 2018 AND GOVERNMENT CODE § 8698.2)**

The following resolution is hereby offered and read:

WHEREAS, California's Governor Edmund G. Brown, Jr. and the members of the California Legislature have recognized the urgent and immediate need for funding at the local level to combat homelessness;

WHEREAS, The Governor and Legislature have provided funding to local governments under the Homeless Emergency Aid Program as part of SB 850 and the 2018-19 Budget Act (Chapter 48, Statutes of 2018);

WHEREAS, The Governor and Legislature require jurisdictions seeking an allocation through the Homeless Emergency Aid Program to declare a Shelter Crisis pursuant to Government Code §8698.2;

WHEREAS, the County of San Luis Obispo has developed a homelessness plan and undertaken multiple efforts at the local level to combat homelessness;

WHEREAS, the County of San Luis Obispo finds that 1,125 persons within the County of San Luis Obispo are homeless and living without shelter;

WHEREAS, the County of San Luis Obispo finds that the number of homeless is significant, and these persons are without the ability to obtain shelter;

WHEREAS, the County of San Luis Obispo finds that the health and safety of unsheltered persons in the county is threatened by a lack of shelter;

WHEREAS, the County of San Luis Obispo affirms the County's commitment to combatting homelessness and creating or augmenting a continuum of shelter and service options for those living without shelter in our communities;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Supervisors of the County of San Luis Obispo, State of California, that a shelter crisis pursuant to Government Code §8698.2 exists in San Luis Obispo County, and authorizes the County's participation in the Homeless Emergency Aid Program.
